The programme enables stronger workplace cooperation and dialogue between management and employees as a mean to jointly address challenges at the workplace. The Swedish Workplace Programme is implemented in partnership with IF Metall, funded by Sida and runs between 2019 and 2023.

#### The Scope of Work

Under these TORs, SWP is seeking for applications from interested facilitators and trainers that can be called upon. Specifically, under these TORs, the trainers, and facilitators(s) are expected to submit a proposal that outlines their capacity to deliver in either of the below areas:

- Leadership
- Negotiation

- ii. A proposed structure on how you would structure a training.
- iii. A framework for monitoring and evaluating the success of the intervention.
- iv. Covid-19 preparedness whether you can/ how you can deliver on an online capacity.
- v. Include a list of at least three reference from your previous clients in your application.
- vi. Indicate the languages you can deliver in should the audience not be proficient in English.



Your proposals will be kept in the SWP consultant's database and you will be called upon when a relevant training is to take place in your area of expertise, should you be available for this. Engagement for the successive steps and possible contract extension will be based on the successful undertaking of previous deliverables.

#### **Qualification and competencies**

- Prior work experience in the relevant field industrial relations, labour market and relations, public policy, international development, political economics, labour systems management, or other relevant themes as outlined above.
